Subject: Authorization to release information to GreenSoft Technology, Inc.

Dear Supplier,

Creation Technologies is committed to providing its customers with products that meet the highest standards of innovation, performance and environmental safety. Achieving this requires the ability to quickly adapt to new industry standards and environmental declaration requirements, such as:

- RoHS-2 (per EU Directive of 2011/65/EU and EU Directive of 2015/863/EU, which includes 4 new phthalates added on top of the original 6 substances)
- REACH SVHC (per EU Regulation EC/1907/2006)
- REACH Annex-17 (per EU Regulation EC/1907/2006)
- Medical Devices Regulation (per 2017/745/EU)
- California Proposition 65 (per The Safe Drinking Water and Toxic Enforcement Act of 1986)
- Halogen Free (per IEC 61249-2-21 and IPC-4101B)
- Hexavalent Chromium
- Persistent, Bioaccumulative, and Toxic (PBT) substances as restricted under US Code of Federal Regulations title 40, part 751, subpart E

 "Regulation of Certain Chemical Substances and mixtures under section 6 of The Toxic Substances Control Act" (TSCA)

Creation Technologies has contracted with **GreenSoft Technology** (www.greensofttech.com) to work with our suppliers in collecting component information. As you may be aware, the EU REACH regulation adds new candidates to the Substances of Very High Concern (SVHC) list of materials to be declared every 6 months. Ideally, GreenSoft likes to have Full Material Disclosure (FMD) on as many devices as possible, thus eliminating the need to continually contact you when new substances are added to the SVHC list. **If GreenSoft is not provided with full material disclosure for the components that you sell to** Creation Technologies, **then it will be necessary for GreenSoft to reach out to you at least two times every year**. A timely reply is appreciated.

Please note that Creation Technologies might not purchase directly from your company. Our distributors may be listed as the purchaser of record.

Pressure from the market and regulatory agencies make this information mandatory for Creation Technologies to collect and provide. In the near future, Creation Technologies will have to decide which suppliers are able to provide not only high-quality, on-time delivery of product and services (per order), but also which are able to support Creation Technologies in its environmental and social responsibilities.

Thank you for understanding our position. We hope that you will continue to support Creation Technologies and GreenSoft by providing the required information.
